### **Review of Minutes of October 2, 2012:**

- Page 3, paragraph about Utility Poles, strike the word "Town" from next to last sentence.
- Motion made and seconded to Accept the Minutes of the October 2, 2012, Board Meeting as amended. Vote was unanimous to Accept as amended.

# Reports of Activities/Committees/Subcommittees:

## Water Quality:

- Bill Conley reported that at the committee's early meeting they covered a lot of ground. Attempts are being made to meet with Mike Collins regarding generating goals and ideas. Will try to get a map for presentation at our Annual Breakfast. Data gathering on Solar Bee. May invite Waxman, Collins, and other interested members to attend a future meeting and will keep everybody informed.
- As an aside, it was mentioned that at the end of August the Governor signed legislation to restrict phosphorus in fertilizers effective 1/1/2014. It will be administrated by Department of Agriculture. This states we must use fertilizer with very low levels or no phosphorus. There will be penalties for those who don't comply. This applies to homeowners and landscapers.
- An Environmental Science Club has been started at the High School. Teacher Scott Lashmit is interested in getting in touch with FOLQ.

#### Web site:

- Ed Spaulding has included water sampling data for May on the Web Site. Jim Murphy has compiled some historical data that may be used for trending.
