Water Testing

- Jim Murphy reported the next scheduled testing is for August 18.
- He also reported that the Conservation Commission has asked for help with evaluating the Solarbee apparatus for improving the water quality of the lake. (Go to http://lakes.medoraco.com/ for more information.) Education to encourage less use of phosphates in the watershed area is one component. He will have more information for the October meeting. The Commission has asked for copy of the lake survey.

Goose Committee

New Business

- A motion to form a Water Quality Committee of Board members Anderson, Butler, Conley and Given to look at issues and possible actions regarding storm water runoff passed unanimously.
- Karen and Jim informed the Board of payment of \$645.00 in discretionary money to get the goose prevention person in place as quickly as possible. It was recommended by members that town budgeting change to allow an earlier start for the program. This should be a goal for next year.
